### **Focus On Marketing**

#### **Using the Affordable Care Act to Market Your Business**

As most of you now know, the provision of the Affordable Care Act that requires insurance companies to cover "lactation counseling" went into effect in January of this year. As policies come up for renewal, the new benefit kicks in. Insurance companies are scrambling to come up with their own interpretation of "lactation counseling" and determining what coverage they will provide. USLCA is working hard to communicate that IBCLC certificants are best qualified to provide this care, and some insurance companies are getting the message.

This summer, USLCA hosted webinars about billing insurance companies and credentialing with Aetna. These webinars are available on CD-ROM at <a href="www.uslca.org">www.uslca.org</a>. While they provide a foundation, be aware that the "game" is changing day by day and area by area. Those who have credentialed with Aetna and other insurers are learning how to code visits and many are finding that they need to re-design the way they provide services. For example, to make sense financially, they may need to see families for shorter visits, but with the pay off of being able to follow them for five or six visits. Clients may benefit by receiving care in bite-sized pieces, rather than a feast of information all at once. Lactation professionals may find that they come out ahead while improving care by seeing families multiple times, rather than provide often uncompensated follow-up by phone or other device.

How can an IBCLC who credentials with insurance companies market her practice? Here are a few ideas to get you started.

- Send post-cards and e-cards to referral sources with your business name and logo, announcing that you now participate with the insurance company.
- Make sure to highlight your in-network status on your website.
- Since the coverage provides for counseling/education, offer prenatal, getting started, and back-to-work classes at local OB/GYN and pediatric offices. Bill insurance for members attending the class. Your engaging, on point, and evidence-based classes will feed your private practice, as well.
- Hospital lactation consultants may want to work with their billing office to explore the
  possibility of credentialing in order to bill for out-patient breastfeeding classes and
  consultation.

This is new terrain for all of us. If you have an idea or experience to share, please let us know. In the meanwhile, USLCA will continue to advocate for the IBCLC credential because, as we know, IBCLCs <u>make the difference</u>, the <u>documented</u> difference!

#### **US Breastfeeding Committee Survey To Assess "Landscape Of Breastfeeding Support"**

The U.S. Breastfeeding Committee wants to learn about organizations, programs, and projects across the Nation that are currently working to support breastfeeding families, and those that could have a significant impact if engaged in this work. The survey seeks to gather information about organizations, programs, and projects that are currently active, and about those that *could* have a significant impact if engaged, in the following four areas:

- · Mother-to-mother support and peer counseling
- Access to services of International Board Certified Lactation Consultants
- Community-based organizations that promote and support breastfeeding, especially in communities of color
- Continuity of skilled support between hospitals and community settings.

#### Have You Ever Wondered About The USLCA Logo?

The logo was created by Judy Harris, MPH, RD, CD, IBCLC, and a member of the original USLCA board of directors in 2006.

It was designed with lines to represent and emphasize the mother and baby being united, laced, and intertwined together as a breastfeeding dyad. Thus the top line represents the mother and the right line the baby. The lines were created like ribbons showing the ebb and flow of the breastfeeding experience and in their dance together. The ribbon line in the lower left corner is the IBCLC, separate from and not touching, but supporting the dyad. The colors of red are for the secretory function of the endocrine system and compassion of the heart as well as with the added white and blue, representing the United States of America. The logo was designed to have a clean, abstract and professional look for a national association and that is different from other organizations such as coalitions.



## Federal Breastfeeding Working Group Seeks Individuals to Create National Breastfeeding Research Consortium

The Federal Breastfeeding Working Group is seeking nominations for the creation of a National Breastfeeding Research Consortium. This consortium is being formed to fulfill item 18 in the *Surgeon General's Call to Action to Support Breastfeeding-*-"strengthen existing capacity and develop future capacity for conducting research on breastfeeding." This consortium would help to prioritize key research areas, increase the generalizability of research on breastfeeding, enable expanded and advanced research to be performed, and foster the timely translation of research into practice. Approximately 15 experts in breastfeeding and lactation research will be selected to a 3 year term. 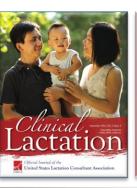
#### mPINC Survey To Be Repeated—With Your Help!

The Centers for Disease Control and Prevention (CDC) is seeking approval from the Office of Management and Budget (OMB) to repeat the Maternity Practices in Infant Nutrition and Care survey (mPINC) for the years 2013 and 2015. Since 2007, the mPINC survey has served as a catalyst for hospitals to improve their breastfeeding support through changes in practices and care processes over time. The CDC is requesting comments from the public on the importance of continuing this survey. It is important for breastfeeding advocates to provide comments regarding the effectiveness of the mPINC survey and the necessity of continuing to have access to a tool that has proven to be so effective in causing change. Comments are due in 60 days (April 13, 2013). The entire request for public comments can be found <a href="here">here</a>, which has background and instructions for submitting your comments.
