Legislative Update

The good news: Medicaid now covers IBCLC services in the state of New York.

The bad news: The IBCLC must be a licensed health professional (RN, MD, PA, NP, etc.) in order to be paid as an IBCLC.

We are making progress in gaining recognition for the value of IBCLC services. This is a prime example of why we need licensure. In almost every state, Medicaid requires that health care professionals be licensed.

Supporting Working Moms Act Introduced

From the US Breastfeeding Committee comes the exciting news of more help on the way for employed breastfeeding mothers.

On Monday, the <u>Supporting Working Moms Act of 2013</u> (SWMA) was introduced in both houses of Congress! SWMA would protect and expand working moms' right to breastfeed by extending the <u>existing federal law</u> to ensure that an additional 11.5 million executive, administrative, and professional employees, including elementary and secondary school teachers, have break time and a private place to pump in the workplace.

Third Listening to Mothers Survey released

Listening to Mothers III survey results from the third national U.S survey of women's pregnancy and birth experiences has just been released. As with previous Listening to Mothers surveys, the latest data show that risky procedures are overused, many beneficial practices are underused, and all too often women lack the support and knowledge required to effectively navigate their maternity care. Some good news regarding breastfeeding care and services was seen in a comparison among the previous surveys. In-hospital formula supplementation rates fell from 47% in 2000-2002 to 29% in 2011-2012. Hospital provision of formula samples (discharge bags) fell from 80% in 2000-2002 to 49% in 2011-2012. However, breastfeeding exclusivity at 1 week fell from 58% in 2000-2002 to 50% in 2011-2012. Poignant Conference Musings from Regina Roig-Romero

I always enjoy breastfeeding conferences; I have long been a conference-junkie. You probably know the type – the front-row geeks that show up in the main room promptly at 7am to save seats in the first row even before breakfast, that always go to conferences whether or not we even need the CERPs. I am one of those. And what's not to love about a good breastfeeding conference? Even if things aren't perfect, a good breastfeeding conference is always worth it to me. The sessions invigorate me, breastfeeding still fascinates me, and there is still a lot for me to learn. Then there's the whole idea of getting away from home, away from work, and enjoying a few days in a nice hotel. And I have always found the speakers in our profession to be accessible, down-to-earth and friendly, eager to stick around after their sessions to answer my questions.

But by far my favorite thing about breastfeeding conferences has always been the people – my colleagues. The colloquial term for this is "networking", but I don't like it; it sounds self-serving to me, as if the main point of networking is to advance one's career. It isn't! I enjoy meeting other IBCLCs, making new friends, and reconnecting with old ones. I love the sharing that goes on – the sharing of opinions, perspectives, and experiences. I love the debates, the dreaming about the future of breastfeeding promotion or our profession, and the vision-building conversations that can occur. Surgery to remove and biopsy it will soon be taking place; only then will I know for sure. However, the diagnosis only made me more eager to attend the conference, not because of the sessions, as much as I wanted to see them, but because of my "conference buddies."

Ours is a profession dedicated to caring for people, to caring for vulnerable women. This week at the USLCA conference I was one of those women, and my friends throughout our profession took me, literally and figuratively, into their arms. One after the other friends both old and new encouraged me, hugged me, consoled me, listened to me, affirmed me, and reminded me of why I want to beat this disease, should the biopsy turn out to be as serious as expected. Had I not gone to the conference, I would have entered into surgery next week without all of that. So don't ask me how much the conference cost me, whether the food was good or the hotel room nice, or how much vacation time I gave up for it, at a time when one could argue that I should have been saving both that money and those vacation hours for the cancer battle to come. Don't ask. Because what I got out of attending this year's USLCA conference is priceless to me.....and in my opinion will make me more likely to be ABLE to attend the next one.....

- •increase political action for governments to regulate the marketing of products covered by the Code and resolutions.

Book Review: Breasts: A Natural and Unnatural History by Florence Williams

An engaging narrative about an incredible, life-giving organ and its imperiled modern fate

Did you know that breast milk contains substances similar to cannabis? Or that it's sold on the Internet for 262 times the price of oil? Feted and fetishized, the breast is an evolutionary masterpiece. But in the modern world, the breast is changing. Breasts are getting bigger, arriving earlier, and attracting newfangled chemicals. Increasingly, the odds are stacked against us in the struggle with breast cancer, even among men. What makes breasts so mercurial—and so vulnerable?

In this informative and highly entertaining account, intrepid science reporter Florence Williams sets out to uncover the latest scientific findings from the fields of anthropology, biology, and medicine. Her investigation follows the life cycle of the breast from puberty to pregnancy to menopause, taking her from a plastic surgeon's office where she learns about the importance of cup size in Texas to the laboratory where she discovers the presence of environmental toxins in her own breast milk. The result is a fascinating exploration of where breasts came from, where they have ended up, and what we can do to save them.
